UPDATE

Happy New Year! Gathering during this festive time of year it is always nice to take a moment to reflect on the past year, the projects, accomplishments, the learning lessons, and take with us what we can and what will lead us into a focused and productive new year. As such, I am pleased to provide the board with some highlights that wrap up 2024 and start us off in 2025!

2 North

Ongoing from 2024 is 2N, our 20-bed unit that remains open to support the prolonged capacity pressures with our acute care partners. Our team has begun developing a ramp down process, which is anticipated for the end of March 2025.

- Total Admissions since opening (Sept.19 Dec 19): 83 Patients (65 direct admits from other hospitals, 18 transitioned from HDGH Rehab/CMC beds.
- Total Discharged from 2 North (Sept.19 Dec 19): 74 (6 to acute, 68 to LTC)

Monthly Education Sessions

A highlight to our Strategic Initiative on "Staff Development", our Clinical Practice Managers have provided ten (10) monthly voluntary education sessions in 2024. Topics varied according to educational needs and trends identified from review of our safety report incidents and from staff feedback. A total of 281 participants attended these sessions and were awarded a certificate of attendance for their personal file as part of their Professional Development Plan.

Wound Champion Program

HDGH is investing in creating Wound Champions to assist with increasing the knowledge, skills, and abilities within our current nursing workforce. This investment will create subject matter experts at the front line level throughout the organization to assist, prevent, and invest in early identification and treatment of pressure injuries. There is significant health concern around Hospital-acquired pressure injuries (HAPIs) in Ontario and at HDGH. Wound Champions will work monthly in a supernumerary capacity to complete pressure injury point prevalence studies on their respective units, and will be a valuable resource to their peers.

<u>IPAC</u>

HDGH continues to follow standard precautions and completing point of care risk assessments for masking and other personal protective equipment requirements. We continue to monitor our local epidemiology which includes assessing Hospital Acquired Infection (HAI) cases, number of



outbreaks, community cases, and severity of disease and will make changes as required if numbers increase.

• Total number of Covid vaccines to date: 49

Total number of Influenza vaccines to date: 232

Tecumseh Satellite Clinic

The Tecumseh Satellite Clinic is well underway and its final stages before the soft launch opening anticipated for mid to late February. This site will service clients attending our outpatient programs including Cardiac Wellness, Rehab Outreach, Outpatient Rehab and GAP.

Model of Care (MOC) - Rehab

In the upcoming months, our PMO team along with our Leadership Team will be validating some of the work we have done thus far related to roles and responsibilities with our staff as well work and reviewing opportunities for improvement to enhance the work we do in Rehab and the impact to both patient and staff.

TNI Transformation (Model of Care)

There was endorsement from Ontario Health to move forward with our internal planning. As a result we will be moving into the implementation phase of the Transformation Project in January. More formal communication will follow in February. The TNI Transformation is a collaborative initiative with that involved consultation with over 220 patients, staff and providers in order to enhance the quality of TNI care delivery, evidence-based programming, as well as staff and patient experience in accordance with best practices and HDGH strategic plan initiatives.

2024 served as a time of flux and positive change for our organization. As president, it's been an exciting time to witness how these changes have come forward and the impact they've had on our institution.

We entered the year continuing to manage the repercussions of Code Grey. While this was an unfortunate and difficult situation we found ourselves in, it forced us to re-examine elements of safety, access to information and aspects of the day-to-day operations of our system. I also saw how this situation brought forth tremendous reliance, teamwork, and the spirit of what it means to be part of Hotel Dieu Grace Healthcare.

As the year unfolded, we enthusiastically welcomed new staff in the areas of geriatrics, anesthesiology, and rehab medicine among others. We were fortunate to welcome a new operational leader from Bluewater Health, Shannon Landry and a new program medical director of restorative Care, Dr. Charlene Johnston as of April.

We took the time to celebrate the accomplishments of staff who have spent years contributing to our organization. We came together collectively to recognize Dr. Jeff Cohen and Dr. Len Cortese, two pioneers of our hospital system.

The big party was a big success as usual, setting new records in the funding we have available for our patients.

Mental health and addictions underwent some big shifts, moving outpatient mental health programming from the Transitional Stability Center to a new location and spearheading the Schizophrenia Project. We were able to roll out rTMS services for our patients with refractory mental illness as a part of the current neuromodulation program. We saw the introduction of educational rounds in mental health which have been very well received, emphasizing the importance of continuing education and development. In the spirit of learning, we held another successful annual geriatric conference in 2024, highlighting speakers with different backgrounds in geriatric health.

Along with changes in our infrastructure, we look forward to changes in the physical structure of our building, with construction on the new outpatient rehab building starting in the later part of the year.

As we move forward into 2025, we remain committed to our mission; to provide exceptional care for patients and their families. I am inspired by the work that happens within these walls daily, from our frontline physicians and nurses to medical teams and administrative staff. It is your hard work and dedication that makes this hospital the place that it is. I look forward to seeing how our hospital will adapt to changes in technology and medical advancement and will
